



**This is to inform the general public and particularly affected land title holders that the Minister of Federal Capital Territory, Dr. Aliyu Modibbo Umar has following the review of revocation of titles over plots in the FCT between 2004 and 2007 and in fulfilment of the Administration's commitment to the rule of law in governance approved the following:**

**A. The re-instatement of titles over plots on Table 1, earlier revoked for Jabai Lake Resort Scheme but found not to be part of the Scheme and located away from the waterfront. Revocation of titles to plots falling within the Scheme is however upheld.**
